SERVICE FEE SCHEDULE – Effective Jan 1, 2020**

**Access to services:**

Access to services will be based on clinical need. (Priority will be given to pregnant women in need of substance abuse services.) Clients who have insurance not covered by our clinic may need to contact their insurance company for a referral to a network provider. If you have private insurance and choose not to utilize it, you will be charged full cost of services

Psychiatrist Services (APNP / MD appointment)*	\$325/hour
Mental Health Assessment*	\$225
Psychotherapy (counseling)*	\$200/hour
Psychotherapy group sessions*	\$50/hour
Community Support Program/Case Management services*	\$175/hour
Emergency Services (for face to face sessions; mobile, walk-in included)*	\$175/hour

AODA Assessment*	\$225
Psychotherapy (counseling)*	\$200/hour

## Polk County Behavioral Health Services SERVICE FEE SCHEDULE

### **Sliding Fee Schedules:**

Residents with no insurance and a demonstrated financial need may be eligible for reduced rates on a sliding fee schedule. The sliding fee schedule, ATP, financial assessment is based on the State of Wisconsin's Uniform Fee System. As a County provider reduced rates and county funding will only be considered for clients without other funding sources.

To determine eligibility for a sliding fee schedule (ATP), contact our office at 715-485-8400 to set an appointment (they will let you know what paperwork to bring with to the appointment). Services offered in the clinic that are eligible for a sliding fee schedule (ATP) are denoted with an \* in the fees listed above.

### **Co-pays, Self-pays, and Deductibles:**

Clients are responsible for full cost of co-pays and deductibles. These fees, along with self-pay services, are not eligible for reduced rates on the sliding fee schedule. Co-pays and self-pay fees are to be paid in full prior to receiving services unless alternative arrangements have been made with the Business and Operations office. If you have private insurance and choose not to utilize the insurance, you will be charged full cost of services.

### **Placements, Emergency Detentions, Commitments and Detoxification:**

Clients who have received one of these service and do not have health insurance to cover this service will be charged Polk County Behavioral Services department's full cost of this care/service. Clients should contact the Intake Specialist or work with their Case Manager to make arrangements for these financial obligations. A sliding fee schedule (ATP) is available for clients in need of this service.
